Overall- \$47,000.00 loss in field house (dome still closed)

<u>MAY 2018</u>

Overall- \$ 28,000.00 loss

Revenue-Ice rentals were up as the ice was kept in longer this season to capture more spring rentals.

-The field rentals down \$27,000 .00 (dome still closed)



<u>JUNE 2018</u>

Overall- down \$47,000.00

Revenue-field rentals were down \$11,000.00 (dome still closed) Expenses- were up \$10,000 due to purchasing soccer nets (insurance will cover)

<u>JULY 2018</u>

Overall- down \$12,000.00 (dome closure impact)

Revenue- Field house down \$6,000.00 Expenses: Bingo jackpot went this month

Year to Date- showing a net gain of \$14,000.00

This does not include the assumed insurance Loss of Revenue payment. Over all budget, with insurance payment, is tracking at \$47 000.00 below budget. This deficit is a result of reduced field house rental during the Oct, Nov and Dec due to Newbridge Academy and Soccer NS reduction in use.
